### Basic Wedding Package Agreement

I, \_\_\_\_\_, herein after referred to as Client, understand and agree that unless payment is made in full prior to the wedding date that the photographer may choose to cancel this agreement and retain deposit as liquidated damages. Deposits are non-refundable for any reason. Alexander S. Labry, herein after referred to as Photographer, agrees to perform services in a professional manner and provide proof compact disc within a reasonable time, usually within ten working days. Client understands and agrees that no warranties are implied or expressed as to the subjective quality of the photographs. Client agrees to allow posting of images on photographer's host site for viewing.

**FINAL ORDER:** Client further agrees to choose prints, images for albums or high resolution files within one hundred eighty days (180) from wedding date and have those choices made known to Photographer in writing by that date. If package choices are not made known to the photographer in writing within 180 days, photographer may, at his sole discretion, void any order. In the event of this occurrence, any and all of Photographer's remaining obligations under the terms of this agreement are null and void and Photographer has fulfilled his total obligations under this agreement. In the event photographer agrees to honor any order beyond the 180 day limit herein established and agreed to - client hereby agrees to pay a \$350 restoration/storage service charge to reinstate the order.

**SERVICE COVERAGE:** The parties agree that Photographer will furnish the services beginning one to two hours before the wedding ceremony until the conclusion of the event or for a maximum period of six (6) hours, whichever is less.

**LIMITATION OF LIABILITY:** *While every reasonable effort will be made to deliver outstanding photographs of Client's event, Photographer's entire liability to Client for any claim, loss, or injury arising from Photographer's performance is limited to a refund to Client of fees paid. Because this is an uncontrolled event, we cannot guarantee the delivery of any specifically requested image (s). In the unlikely event of personal illness or other circumstances beyond the control of Photographer, a substitute photographer of high qualifications may be dispatched by us to fulfill the obligations of Photographer herein contracted.*

**FEDERAL COPYRIGHT LAWS:** Photographer owns all copyrights for any and all images produced in connection with this agreement, including the exclusive right to reproduce or publicly display such images.

**OWNERSHIP OF IMAGES:** Any reproduction of any image produced in connection with this agreement is prohibited without specific written consent of Photographer. Client is hereby authorized to web publish or e-mail images from Proof CD. The parties agree that Photographer may reproduce, publish or exhibit a judicious selection of such photographs as samples of photographic work to be shown to prospective clients, and for instructional or institutional purposes consistent with the highest standards of taste and judgement. Client agrees to hold Photographer harmless against any and all claims arising from any published images.
